More annual maximum dollars for the future

Sun Life PPO dental plans with our RollMax option allow dental members to rollover a portion of their unused annual maximum for use in the future. The additional maximum dollars can be spent on preventive, basic or major covered services¹. RollMax is available with any of our PPO dental plans – including Administrative Services Only (ASO) plans. We have options for any annual maximum amount.

How does RollMax work?

Let’s say you have a \$1,500 annual maximum *plus RollMax* on your plan. When a dental member has paid claims less than \$700 on dental services in a year², they can rollover \$500 for the next year. They can rollover up to \$1,250 over multiple years. This allows dental members to increase their annual maximum dollars for future treatments.
